chair's report

Green Alliance's twenty-first year, and my first year as Chair, has been a dynamic and productive one. A growing budget and staff have enabled us to play an increasingly significant role in the politics and policy of the environment in the UK.

Climate change continues to pose a serious environmental challenge to politicians and policy-makers alike. Green Alliance has contributed to the UK energy policy debate on a wide range of issues, from the climate change levy to utility regulation. Our key recommendations for renewable energy have been adopted by government and our proposal for a sustainable energy agency has been endorsed by the Royal Commission on Environmental Pollution.

Biotechnology policy, too, has remained high on the political and public agendas. Our recommendations and leading role over many years were recognised this year with the creation of the new Agriculture and Environment Biotechnology Commission and the appointment of Julie Hill to the position of deputy chair.

Our political work remains as strong as ever. This year, Green Alliance held seminars with Michael Meacher and William Hague on the Labour and Conservative Party environmental agendas. We've consolidated our links with environmental spokespeople and MPs from all the major parties, and have held dinners and other events on the politics of the environment.

Organisationally, Green Alliance has gone from strength to strength. We have appointed an excellent new director in Paul Jefferiss and attracted increased funding for two new staff positions. This expanded base will provide a firmer foundation for future growth.

Over the next twelve months, in addition to continuing our work on energy, biotechnology and waste, we will look at interactions between the new economy and the environment, explore the relationship between environmental and social exclusion, and investigate the role of precaution as a principle of decision-making. Above all, we will attempt to ensure that the environment is a central political issue for all the major parties in the run up to the next general election.

On behalf of the board, I thank Peter Madden, who left Green Alliance during the year, for his immense contribution to the organisation and to environmental policy and politics over the past two and a half years, and wish him every success at the DETR. I thank all Green Alliance staff for contributing to another extraordinarily successful and productive year.

I look forward to making the coming year even more remarkable than the last.

We aim to challenge conventional wisdom, offer new insights into environmental issues and identify opportunities to reinforce the importance of the environment, especially in the political sphere.

... about difficult issues

This year we focused on risk and scientific uncertainty and the limitations of government decision-making mechanisms. Two Green Alliance seminars, early in 2000, brought together government, academics, scientists, business and NGOs. They identified what should be the essential elements of a government policy response to scientific uncertainty. The results of these seminars and our own research on the subject, along with practical policy recommendations, were presented in the briefing *Steps Into Uncertainty: Handling risk and uncertainty in environmental policy-making* (June 2000), published jointly with the Economic and Social Research Council.

... about new agendas

In 1999 we introduced the *New Politics* pamphlets, a platform for innovative thinking on political agendas and the environment. The series was launched with the publication of *Sustaining Europe: A common cause for the European Union in the new century* (November 1999) in which Ian Christie suggests that sustainable development should be adopted as the new mission for the European Union in the 21st Century. This visionary proposal has served to stimulate discussion on the subject and European environment commissioner Margot Wallström has since promoted the idea.

The next two pamphlets, published in autumn 2000 are: *Mind Over Matter: Greening the new economy* by Charles Leadbeater and *In Our Backyard: The social promise of environmentalism* by Ken Worpole.

... about policy solutions

We produce reports of our own policy research, always concluding with practical recommendations. We considered the views of a wide range of NGOs and energy organisations in our report *New Policies for Renewable Energy* (July 1999). The report was highly influential and its proposals have been taken up by Government almost entirely in its new policy on renewables. Analysis of topical policy issues is the focus of Green Alliance's quarterly report *Inside Track*, to which guest writers also contribute their views. Well known personalities have addressed a diverse range of issues throughout the year including: the impact of devolution on sustainable development policy; the greening of the World Trade Organisation; and the pros and cons of a new government department of rural affairs.

bringing people together...

In its wide network of members and contacts, Green Alliance has a formidable pool of intelligence and expertise. During the year we held 24 seminars, seven dinners and four major debates for senior environmental policy practitioners on subjects ranging from the promise of an environmentally modern economy to the content of the Conservative party's environmental policy.

We hosted speeches by, among others, the Deputy Prime Minister, the Rt Hon John Prescott MP; EU Environment Commissioner, Margot Wallström; the Government's Chief Scientific Adviser, Sir Robert May; the influential US thinker and author, Amory Lovins; and the Conservative leader, the Rt Hon William Hague MP.

breaking the ice...

Not all our meetings are strictly policy oriented, some are intended simply to connect different sectors and forge new links. This year we held our second annual 'green quiz', chaired by the environment journalist Geoffrey Lean.

We also held a summer reception at the Institute of Contemporary Art.

advising government...

Julie Hill, Green Alliance's programmes adviser, contributed to a number of bodies providing advice to government on the issue of genetic modification. She was also a member of the working party which produced the much publicised report by the Nuffield Council on Bioethics on *Genetically Modified Crops: the ethical and social issues*. Peter Madden was a member of the UK Roundtable on Sustainable Development.

responding to inquiries...

This year we submitted evidence to four inquiries by the Environmental Audit Committee on: genetically modified organisms; the UK sustainable development strategy; environmental reporting by government agencies (three Green Alliance recommendations were taken up) and EU integration (five Green Alliance recommendations were taken up).

We provided consultation responses to all eight Regional Development Agencies on their draft economic strategies and submitted the summary paper *Ten Key Tests for the Regional Development Agencies* to the Department of the Environment, Transport and the Regions (DETR). Thirty of our recommendations were taken up.

working with environmental groups...

Our work with other major environmental groups included steering input and interactions around the proposed climate change levy through meetings between NGOs and environment ministers, and the co-ordination of a joint announcement in the national press. The levy was implemented and amended to increase its environmental effectiveness.

We also co-ordinated lobbying by groups around the autumn 1999 pre-budget statement, leading to two meetings with Treasury secretary Stephen Timms. The budget that followed was considered the greenest yet, with a wide ranging package of environmental measures.

interacting with business...

During the year, we participated in business advisory committees and contact groups, and held lunches and dinners for corporate supporters.

Green Alliance also worked directly with the DTI on their first sustainable development strategy. The DETR took note of our recommendations for performance indicators in the waste industry.

The Green Globe Task Force

The Green Globe Task Force (GGTF) is a network of environment and development policy experts. Its mission is to help the Foreign Office, DETR, and other government departments achieve international objectives for sustainable development through providing advice and developing proposals for new policy initiatives. The GGTF, convened by Fanny Calder, is housed at Green Alliance, but has its own discrete organisational identity. During 1999 - 2000 the GGTF worked on issues including trade and environment, and submitted ideas for a series of Commonwealth workshops on trade and sustainable livelihoods. It made recommendations for bringing governments, civil society and business together at the Earth Summit 2002 to protect shared global resources for sustainable development. It also worked on climate change policy, looking specifically at a strategy to encourage Russia to ratify the Kyoto Protocol.

The European Environmental Bureau (EEB)

As Chair of the UK Conference of the European Environmental Bureau (EEB), a grouping of 20 organisations including many of the major NGOs, Green Alliance plays an important role in shaping European policy. This year, we focused on the proposals for the EU's sixth environmental action programme, co-ordinating NGO input into this important rethink of Community policy. Through our publication, *Sustaining Europe*, we influenced the shape of Europe's sustainable development strategy, working closely with Commission officials and NGOs across the Union. Together with our members, we gave evidence to the House of Commons Environmental Audit Committee on progress toward integration of the environment across EU policy. We also ran eight meetings, four of them with ministers and one with Caroline Jackson, Chair of the Environment Committee in the European Parliament.

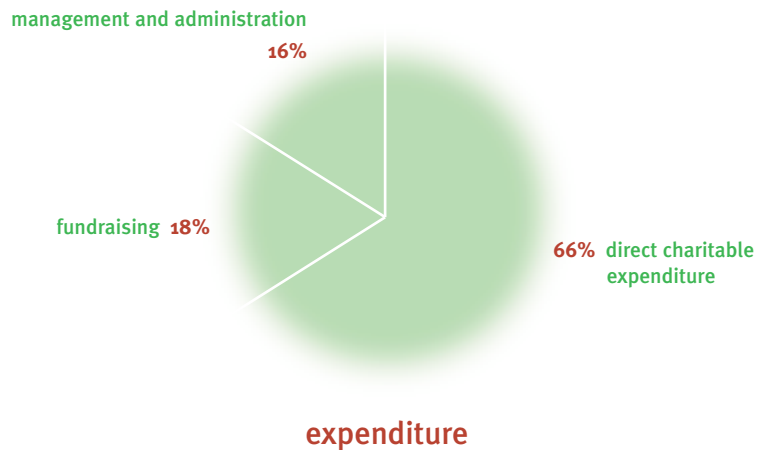
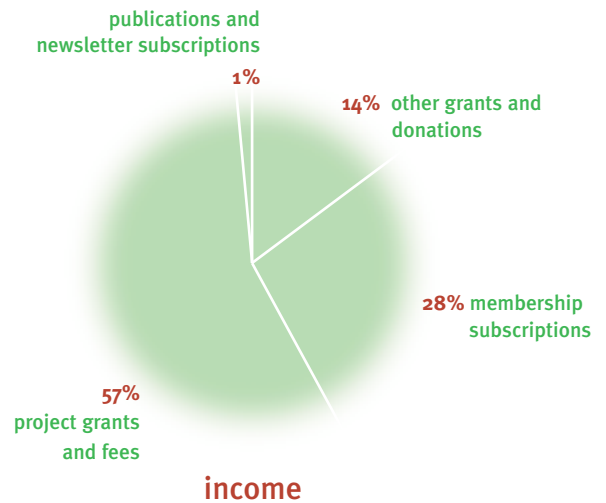

We are once again able to report a substantial increase in income this year, from £237,372 in 1998 to £304,515. The income rise over the past two years has reflected the continuing growth of the organisation. Expenditure has risen accordingly.

Most income growth has been in the area of unrestricted income. The largest part of this figure is £75,000, the first instalment of a three year grant from the Esmée Fairbairn Charitable Trust. We are extremely grateful for this support, which has been given for Green Alliance's programme of work. It has provided a much-needed boost to the organisation, allowing us to plan ahead more effectively and follow our work programme closely throughout the year, avoiding the vagaries of short-term fund chasing.

In 1999 Green Alliance created two new staff posts, moved premises and installed a new computer network. We are fortunate to receive a grant from the Westminster Foundation which directly subsidises our rent payments, keeping these costs beneath the market rate. Charitable expenditure has remained at a similar proportion of total income. The higher relative expenditure on management and administration is due to the focus given to careful planning and management during this period of growth for the organisation.

Overall we are pleased to report that Green Alliance has had a very successful year. The goodwill of our funders and supporters has allowed us to continue the financial progress made during 1998, ending 1999 with a positive balance of £23,555. This amount is designated entirely for projects continuing into 2000.


trustees' statement
